## On the product side, some of the functional changes incorporated:

## **All Products:**

• Update to support "forgot password" handling to allow users to manage their own passwords rather than having an administrator having to change the password.

## **Agency Portal:**

- We are pleased to announce the introduction of **Auto-Save** to the quoting process! We know how important it is to ensure that no work is lost, especially when dealing with complex insurance quotes. This new feature will automatically save the information as the agent progresses through an indication.
- Agents can now add additional attachments to previously submitted pricing indications, streamlining communication and ensuring all relevant information is included.

## **Policy Production:**

- Added enhancements to the Driver screen, designed to improve driver management and
  provide clearer insights for policy processing. These updates include the addition of a
  "Non-Approved Driver" selection and modifications to the duplicate driver results display.
  Drivers marked as "Non-Approved" will be treated the same as named excluded drivers
  regarding policy output, ensuring proper handling in documentation and processing.
- You can now edit any type of remark you've entered in the system up until the Issuance of the application. This update allows you to make necessary adjustments and corrections, ensuring that your remarks are accurate and aligned with your application requirements.
- Modify policy search to include search option by Drivers License # (Auto lines only).


### Claims:

- Introduced a new safeguard to ensure compliance and accountability in managing reserves. The system will now enforce user authority when attempting to make increases or reductions to existing reserves, enhancing control and security.
- To enhance accuracy and ensure proper handling of reserves, we've introduced a new confirmation prompt when users attempt to make a "Final" payment in the Payment Request process. When a user selects "Final" payment, the system will display a confirmation prompt asking them to verify that they intend to close out the reserves for the associated Coverage and Kind (Loss/Expense).
