

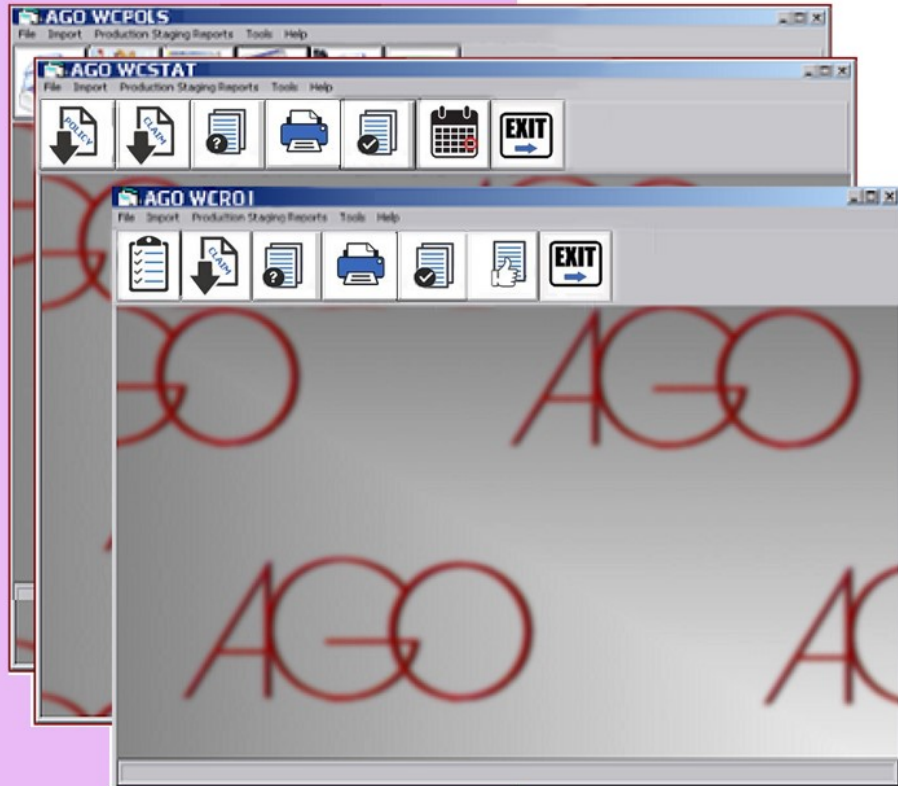
# AGO's Workers Compensation Reporting

The AGO Workers Compensation Reporting Modules support the automated compilation and filing of mandated WCPOLS and WC Unit Statistical Reports to a state bureau or NCCI.

**WCPOLS** complies with the NCCI specifications for electronic reporting format and includes any extensions necessary to comply with the Workers Compensation Bureaus in states independent of NCCI. The system is completely integrated with the AGO Workers Compensation Policy Processing System (WCPPS). With this integration, all transactions processed through the WCPPS generate an interface record to a WCPOLS repository (with the exception of audits-reported through WC Unit Stat). On a scheduled basis, the submission creation program is invoked to retrieve, sort, sequence and output the batch of policy transactions to a submission file. This file can then be emailed to the appropriate bureau.

**WC Statistical Reporting (WCSTAT)** supports the automated compilation and filing of mandated Workers Compensation Unit Statistical Reports to the particular state bureau having jurisdiction over a policy or to NCCI. USTAT complies with the NCCI specification for electronic reporting format and includes any extensions necessary to comply with states that have independent bureaus. The system is completely integrated with the AGO WCPPS and AGO's All Lines Claims Tracking System (ALCTS) for the access and assessment of policy and claims data. The system also has import utilities to allow transfer of either policy or claims data from external systems.

**WC Report of Injury (WCROI)** supports the automated compilation and filing of mandated Workers Compensation First Report of Injury and Subsequent Report of Injury. Claim monitoring, data import, trial runs, and bureau submissions are included.



## Reporting Components

- Policy Import - allowing import from AGO's Workers Compensation Policy Processing System (WCPPS) or a 3<sup>rd</sup> party policy system
- Claims Import - allowing import from AGO's All Lines Claims Tracking System (ALCTS) or a 3<sup>rd</sup> party claims system
- Report Menu - sorts in to three temporal periods: Filing Month, Due Next Month, Due in 2 months
- Submission File Trial Run - produces an image of the submission file without setting status flags or updating.
- Submission File Dump - produces a hard copy listing of the submission file in an easy to read format.
- Clock Maintenance - provides for the setting and advancing of the system control clock, which governs the selection of policies due for reporting to the appropriate bureau.

## System Environment

- System function on a Windows Platform utilizing SQL, Oracle, DB2/AS400 or any ODBC compliant database Platform

## Options

- Integration with AGO's Workers Compensation Policy Processing System (WCPPS)
- Integration with AGO's Claims Tracking System on the Web (CTWeb)
- Custom interfaces can be built.
- These systems may be run as stand-alone modules.
